| <b>Schedules</b>                      | Interlake is open Mon-Fri. <b>Part-time schedules are offered with fixed days of attendance only.</b> The 3 days/week schedule is for attendance on Mon+Wed+Fri. 2 days/week is for Tue+ Thu.                                                                                                                                                                                                                                  |
| <b>Tuition Payments</b>               | Tuition is due on the 1 <sup>st</sup> of each month. <b>Late payments are subject to a late fee equal to \$10 + \$5 for each day after the 1st.</b> Tuition includes the food program, and covers the entire month of care. A monthly electronic invoice is made through Brightwheel. A family may request to pay by check. Checks should be hand-delivered to the office, and be made payable to: INTERLAKE CHILD CARE CENTER |
| <b>Sibling Policy</b>                 | For families with two children enrolled at Interlake, ICC offers a \$100 monthly younger sibling discount.                                                                                                                                                                                                                                                                                                                     |
| <b>Late Pick Ups</b>                  | All children must be signed out by the time the center closes at 6p. <b>ICC reserves the right to apply a late fee equal to \$5 plus an additional \$1 for every minute after the time of closing.</b> Brightwheel attendance log monitors the sign-in and sign-out times. Fees will be applied through Brightwheel.                                                                                                           |
| <b>Refunds &amp; Prorated Tuition</b> | ICC is a not-for-profit, and all tuition is used for program operations. Therefore, <b>tuition is not prorated, and refunds are not offered under any circumstances</b> , including but not limited to: illnesses, absences, vacations, holidays, planned closures, or unplanned/emergency closures. The first and last months of tuition are also not eligible to be prorated.                                                |
| <b>Waitlist or Registration Fee</b>   | In order to join the waitlist, there is a one-time, non-refundable waitlist fee of \$100 per child. For instances of open availability (i.e. the family is not on the waitlist), there is a one-time, non refundable registration fee of \$100 per child. Each family pays only one of these fees, per child.                                                                                                                  |
| <b>Security Deposit</b>               | A security deposit of \$500 is due upon accepting enrollment. The deposit is eligible to be refunded, provided a 60-days notice of intent to withdraw is given (see "Leaving the Program"). The refund will be applied toward the final month of tuition.                                                                                                                                                                      |
| <b>Leaving the Program</b>            | A minimum 60-days official notice of intent to withdraw from care must be given in order to be eligible to receive the deposit refund. "Official notice" can be a written letter, or an email to administration at <a href="mailto:admin@interlakechildcare.org">&lt;admin@interlakechildcare.org&gt;</a> .                                                                                                                    |
